New Haven Community Schools will receive firm prime contractor bids for the labor, materials, equipment, and all other services to complete Boiler Replacement at New Haven Elementary School.

The bidding documents consist of plans & specs prepared by French Associates, 236 Mill Street, Rochester, MI 48307. Documents will be available for download from Pipeline after May 8<sup>th</sup> 2023. A Pre-Bid meeting will be held starting at New Haven Elementary, located at 57701 River Oaks Dr., New Haven, MI 48048, on **Thursday, May 16, 2023, at 1:00 PM.**

The envelope bearing your proposal must identify your company, the proposal being bid and addressed to the attention of Mrs. Cheryl Puzdrakiewicz, Superintendent, 30375 Clark Street, New Haven, MI 48048. Each proposal shall be sealed in an opaque envelope and marked with the name of the bidder. Bids must be delivered no later than **12:00 noon, Thursday, May 25, 2023**, to New Haven Community Schools at the address noted above or AUCH Construction Company, 65 University Drive, Pontiac, MI 48342. **Late bids will not be considered or accepted.** Each proposal must be submitted on the forms furnished by the construction manager and must be completed in full; including the Familial Disclosure Statement and the Affidavit of Compliance to the Iran Economic Sanctions Act and notarized. A bid bond executed by a **U.S. Treasury listed surety company** acceptable to the owner, or a cashier's check in the amount of at least 5% of the sum of the proposal payable to New Haven Community Schools shall be submitted with each proposal in excess of **\$28,048.00**. All proposals shall be firm for a period of **sixty (60) days**. Electronic bid submissions will not be accepted.

Bids will be publicly opened and read at a meeting convened via Zoom from the New Haven Administrative Office (main board room) starting at **2:00 PM, Thursday, May 25, 2023**. Successful bidders whose proposals are \$50,000 or more will be required to furnish a Satisfactory Performance and Payment Bond in the amount of 100% of their bid. The cost of the Bond shall be included in each proposal.
